- Since the Company has only one Segment i.e., Property Development, separate disclosure on segment reporting as per AS-17 issued by the ICAI is not required.
- The useful life of fixed assets has been revised in accordance with Schedule II of the Companies Act, 2013. Accordingly, depreciation of 3 ₹ 20.01 Lakhs on account of assets whose useful life is already exhausted as on April 01, 2014 has been adjusted to opening reserves. On account of change in the useful life of fixed assets the depreciation expense for the quarter is higher by ₹ 3.52 Lakhs.
- With effect from May 16, 2014 SSPDL Infratech Private Limited (Formerly SSPDL Interseve Private Limited) has become a wholly 4 owned subsidiary of the Company.
- The figures for 3 months ended March 31, 2014 are the balancing figures between audited figures in respect of full financial year ended 5 March 31, 2014 and the unaudited published year to date figures up to the third quarter of that financial year.
